

2010 Sandwich Antiques Market

SANDWICH, ILLINOIS

I hereby make application to JLC Antiques Show Management (the "Management") to obtain a license for exhibitor space at the *Sandwich Antiques Market* at the Sandwich Fairgrounds, Suydam Road, Sandwich, Illinois (the "show"), on the dates noted on the first page of this application, *rain or shine*. Management reserves the right, in its sole discretion, to accept or reject your application. Providing your credit card number by telephone is equivalent to signing this application. The deposit or processing of the payment made with this application is the Management's acceptance of your application. By signing and submitting your application, you agree to and will be bound by the terms set forth below, in the attached Show Rules and Conditions, and in the attached Special Reminders. Upon acceptance of your signed application, these documents will form the final, complete and entire agreement between you and Management.

Release. You agree to release the Management and the Sandwich Fair Association, Inc. (the "Association"), and their agents and employees, from any loss, cost or damages that you or any of your employees, agents or invitees may suffer or incur due to personal injury or death, or property loss or damage, arising from any cause whatsoever while on the Show grounds, whether caused by your negligent or intentional acts or omissions, the negligent acts or omission of Management or the Association (or their employees or agents), or any acts or omissions beyond the control of Management or the Association. Management provides no insurance on your behalf. All insurance must be secured and paid for by you.

Refund Policy: No Liability. Management seeks to provide a safe, clean and physically attractive Show environment, but provides no guarantee. Your payment for booth rent and table rental is non-refundable. The Show takes place, *rain or shine*. Management will not refund booth, table or tent rent nor pay any financial compensation to you for any expenses, lost sales or lost profits, whether the Show must be cancelled or must be held in or on facilities that have been diminished beyond the expectations of the Exhibitor. This policy applies to any situation, and includes (but is not limited to) any events beyond the control of Management: i.e. fire, flood, loss of electrical power, any weather related condition, act of God, change in the policies or procedures of the Association, or the alteration, construction or reconfiguration of the Show grounds, etc.

Indemnity. You agree at all times to indemnify, and hold harmless the Management, its agents and employees, from and against all claims, demands actions or causes of actions, losses and costs (including reasonable attorney fees, court costs and other litigation related expenses), which are incurred by or assessed against Management, its agents or its employees, as a result of any loss or damage to property, injury or death of persons, or any false representations as to any merchandise sold by you, which may be due in any manner to or caused by you, or your agent's employee's or invitee's acts or omissions, or any of the acts or omissions of the Management.

License for Exhibitor Space is Non-Transferable and Revocable. The license granted to you for exhibitor space at the Show is non-transferable. You may not "sub-let" your booth to someone else, or allow another party to share your exhibitor space. You must notify us if you are going to be absent from the Show. Leaving a booth empty jeopardizes your continued participation in the Show. The license granted to you for exhibitor space at the Show is revocable, with or without cause, at any time, in Management's discretion. Once you contract for a booth space, tent and/or table(s), you are required to pay for it/item. If you fail to exhibit at the Show you are still obligated to pay the full amount.

Merchandise Quality Standards. The Show is an "Antiques Market" and only antiques are to be presented for sale with this contract. "Adaptive Reuse" items are contained in another area and require a different contract. **New, reproduction, container merchandise, craft or flea market merchandise or items are PROHIBITED in East Field.** All collectibles must be out of production, at least 20 years old, must have had monetary or artistic value when originally made, and must not be available through catalogs, or other non-antique commercial venues. Merchandise is subject to Management review at any time. If Management determines in its discretion that merchandise does not conform to Show standards, it must be removed. If multiple violations occur, Management may revoke your license for exhibitor space and upon such revocation you must pack and leave the Show — without refund.

Only one vehicle per booth unless pre-registered by Monday before the Show. No exceptions. Unregistered vehicle will be charged \$30 per vehicle.

No shopping from any wheeled vehicle, except wheelchairs.

Local ordinances and insurance restrictions do not allow overnight parking on the fairgrounds or adjacent streets on Friday and Sunday nights.

You must arrive by 7 a.m. on Sunday. We will not "hold" your booth after 7 a.m.

You must be packed and depart from the fairgrounds by 9 p.m. Sunday. Any Dealers not ready to leave by Sunday, 9 p.m. will be charged a Late Departure fee of \$30 per hour or any part thereof.
